- REIMBURSEMENT OF **\$400.00** TUITION FROM THE UNION HALL
- CREDIT OF **\$50** FROM THE UNION HALL FOR TWO MONTHS UNION DUES (MEMBERS RESPONSIBILITY TO MAKE SURE UNION DUES ARE PAID UP TO DATE. CREDIT ONLY APPLIES AFTER WE RECEIVE CONFIRMATION YOU HAVE COMPLETED A PERIOD OF TECHNICAL TRAINING)
- UP TO **240 HOURS** INTO YOUR PBAS HEALTH AND WELFARE BENEFIT HOUR BANK ACCOUNT (TRANSCRIPT FROM SCHOOL MUST SHOW HOURS ATTENDED).
